Right to Cancel/Rescind	You will receive a notice from your Utility confirming your selection of SmartEnergy as your provider. You may rescind the enrollment by contacting your Utility within seven (7) days following the date of the letter. You may contact the Utility or orally, electronically or in writing. Once you are enrolled, you may cancel this Agreement at any time, for any reason, without fees or penalties. To cancel, you may contact SmartEnergy by mail, telephone, or electronically at the contact information provided above.
Cancellation/Early Termination Fees	None
Renewal Terms	SmartEnergy will send you a renewal notice at least 45 days prior to the expiration of this Agreement with new terms. If you do not affirmatively consent to the new terms, we shall either return you to being served by your Utility (basic generation service) or continue to serve you on a month-to-month term under current contract terms.
